MASTER'S THESIS (UNIVERSITY OF ROCHESTER)

“The Silence Is Broken: A History of the First Lesbian, Gay, and Bisexual College Student Groups”

This work examines the creation and development of the Student Homophile Leagues at Columbia University and Cornell University, the first lesbian, gay, and bisexual rights organizations established at U.S. colleges. While largely overlooked by historians, these groups helped lay the groundwork for a militant gay liberation movement to emerge following the Stonewall riots.

DISSERTATION

“A Queer Capital: Lesbian, Gay, and Bisexual Life in Washington, D.C., 1890-1955”

Using oral histories, archival material, and the works of early twentieth-century writers, this study traces the impact of race, class, and gender differences on Black and White lesbians, gay men, and bisexuals in the nation's capital prior to the rise of the homophile movement.
